Please Note: Whether you are paying in cash or with a cashier's check, we need for the cost of the animal to be separated from the cost of pen rent. (Ex: Steer = one cashier's check for \$2120.00 for the animal/entry and one cashier's check for \$200.00 for pen rent)

Tattoo Date: January 8, 2017 from 3-5 pm in the CSHS Ag Shop (tattoo all of your babies)

Pens: Animals must be kept at home.

Total: \$20.00 (Entry Fee)

For each project, the student is responsible for securing feed and ensuring the animal is cared for. Eligibility check will be completed for the 2nd Nine Weeks grading period, January 12, 2018 (the “No pass, No play” rule is in effect). If an ineligible student has a project in the barn, the animal will have to be removed from the barn by January 22, before the start of the 2018 CCISD Livestock Show and Auction. You must be enrolled in one agriscience course to be eligible to exhibit a project.

Purchase of a livestock project(s) is not required of a student to be enrolled in an agricultural course or to participate in the CCISD show and auction. Students may also enter Ag. Mechanics, Floriculture, Horticulture, Visual Arts and Food Science projects to be a participant of the show and auction. Each exhibitor must be a paid FFA member in good standing with their respective chapter.

In addition to the payment of the project, students need to turn in an entry form, a W-9 with **student information**, a signed show rule agreement, a signed animal health care guidelines, and a signed barn rule agreement (if the project is kept in the barn) to their ag science instructor prior to selection.

Please note that if you plan to participate in the CCISD Livestock Auction, you will need to have official dress in order to Auction. Please see your Ag. teacher for details.

Failure to attend and sign-in at the mandatory clean-up sessions posted above will result in a \$100 fine for each session.

General Rules

1. The agriscience teachers of this school district and the appointed show officials under their direction, reserve the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard and hereto otherwise arising out of, connected with, or incidental to this educational event. This governing body is later referred to in this instrument as the “Management”.
2. The show Management reserves the right to amend and/or add to these rules and regulations as it, in its judgment, may deem advisable. Management authority and responsibility are limited to those activities and events directly related to and being part of the CCISD FFA Livestock Show and Auction Schedule and Rules.
3. The Clear Creek Independent School District, its employees, and appointed show officials will not be liable for any damage(s) resulting from fire, theft, accident, injury or any other adverse situation(s).
4. The agriscience teachers will strictly regulate any and all construction building or site modification and/or introduction or use of equipment. Prior CCISD administrative approval is required. The agriscience teachers will make appropriate pen assignments for animals brought into the West Agricultural Facility for the week of the Livestock Show and Auction. Animals housed at the West Agricultural Facility may be reassigned temporarily during the show. Assignments will be determined by agriscience teachers.
5. The show facilities will be closed at 9:00 p.m. or when the last show is completed for the evening, whichever comes last. It will reopen at 5:00 a.m. on all show days except for the morning following the live auction. On the day following live auction, the barn will not officially be open to the public until 1:00 p.m. If students have an animal that needs to be fed on that morning, it is the responsibility of the student to leave out the right amount of food that needs to be fed to the animal so that the show management team can feed.
6. All alcoholic beverages and tobacco products are barred from the show grounds as per state statutes and local CCISD rules and regulations. Any person caught with an alcoholic beverage or tobacco product will be removed from the show grounds. If that person has an animal project to show, he/she will be barred from further competition and will be reported to proper authorities for disciplinary action.

7. Protests: All protests must be made in writing and submitted to a committee consisting of the agriscience teachers, the Show Chairman and the CCISD CTE Administration by 12:00 p.m. January 30, 2018 along with a \$250.00 cash fee, which will be forfeited if the protest is not sustained.
8. Foods and soft drinks will be offered for sale by CCISD FFA Booster Clubs, utilizing the provided concession area.
9. Inappropriate behavior, gestures or offensive language will not be tolerated. District code of conduct will be enforced. Consequences will vary depending on severity.
10. Exhibitors must be enrolled in at least one semester of an agriscience course in the Clear Creek Independent School District during the 2017-2018 school year. Exhibitors must also be paid FFA members in good standing and have satisfactory class attendance records.
11. A student will be eligible to participate for only four years, as defined by school district policy.
12. Exhibitors must abide by all rules in accordance with local district policy regarding eligibility for participation.
13. Each exhibitor must own his/her animal at the beginning of and throughout the feeding period and must feed, care for, and exhibit his/her own animal. Any break in the ownership or enrollment in CCISD agriscience program forfeits animal and or exhibit entry. Exhibitors may only exhibit the designated livestock project officially tagged in their name on the designated selection day.
14. In case an exhibitor is unable to check in his/her project, with prior notification, the project may be checked in by another FFA student, teacher or parent. Projects may only be checked in during designated times. There will be no early or late check-ins.
15. Substitution exhibitors will be approved by the agriscience teachers.
16. Exhibitors will not be allowed to stay overnight on the show grounds.
17. Hats or caps on exhibitors will not be allowed in the show ring.

18. All students who have assigned facilities and/or used facilities at the FFA project barn before and during the auction, must leave the facility clean, in a sound state of repair.
19. Students failing to sign in and participate in show clean up as designated by their agriscience teachers (please see schedule) will be fined a **\$100.00** fee for each session. All stalls and pens at the barn must be cleaned by the Friday following auction. This fine will be deducted from the sale of the livestock project or assessed at the conclusion of the show.
20. All fees, if any, owed to the CCISD FFA Livestock Show and Auction must be paid in full. Students will be checked out officially by their agriscience teacher(s) and respective chairmen. Fees will need to be cleared by March 9, 2018.
21. Exhibitor must be present at time of show.
22. Entry Fee is **\$20.00** for the following categories: Steers, Lambs, Swine, Goats, Broilers, Turkeys, Rabbits, Breeding Heifers, and Longhorns. **Note: These fees are used to help finance show expenses.*
23. Entry Fee is **\$10.00** for the following categories: Horticulture, Floral Design, Visual Arts, Food Science and Ag Mechanics. **Note: These fees are used to help finance show expenses.*
24. Entry forms, fees, and W-9's for Horticulture, Floriculture, Visual Arts, Ag. Mechanics, Food Science, Longhorns, and Breeding Heifers must be submitted by **January 12, 2018**. All entries are submitted to the respective agriscience teachers.
25. All steers, lambs, swine, goats and poultry will be "centrally ordered" through the agriscience teachers. Students will draw for pick out of a group of like steers, lambs, swine and goats. All animals must come from this "central order" to be eligible for competition at the CCISD FFA Livestock Show and Auction. The central producer/breeder will be selected by the agriscience teachers.
26. Each student is allowed to purchase, tag-in, and show only one animal project in each livestock division. However, for Ag. Mechanics, Floral Design, Horticulture, Food Science, and Visual Arts a student may enter in each class within the division (i.e. one fresh floral project and one silk floral project.)

27. Show entries will be limited to the divisions offered.
28. Agriscience teachers are to determine when the judging of classes shall begin. Agriscience teachers will inform the ring steward when students are to enter the arena.
29. All judges' decisions are final.
30. All livestock and poultry entered in the CCISD FFA Livestock Show Auction will be tagged/banded/tattooed when exhibitors select animals under the supervision of the agriscience teachers.
 - If the animal is not tagged/banded/tattooed on the set date, then the student will not be allowed to exhibit the animal at the CCISD FFA Livestock Show and Auction.
 - If an animal loses their official CCISD tag/band(s), the exhibitor must immediately notify their agriscience teacher so that the animal can be re-tagged/re-banded.
 - No non-tagged/non-banded/non-tattooed animal will be allowed to check-in or weigh-in at the CCISD FFA Livestock Show and Auction.
 - The tag/band must remain in place until the show and auction is over and the animals have been officially checked-out by official show representatives.
31. Each exhibitor will feed and care for his/her animal during the entire length of the show.
32. The CCISD Livestock Show and Auction reserves the right to collect a urine sample for laboratorial analysis on all species of Grand Champion and Reserve Grand Champion animals exhibited at the show, and a random draw from each species at show management's discretion. It is the exhibitor's/parents' responsibility to remain with the animal and assist in the collection. Each exhibitor or parent must sign a form indicating that they witnessed the collection of the urine sample. An exhibitor of an animal producing an analysis with a quantity of diuretic, any unapproved medication, or any substance not approved by the FDA will forfeit sales proceeds and will be barred from participation in future CCISD Livestock Show and Auction competitions. All tests will be final without recourse against CCISD Livestock Show and Auction or any of its officers. Upon receipt of test results, checks will be issued to eligible exhibitors.

33. Evidence of the following will result in automatic disqualification from the current year's CCISD Livestock Show and Auction, which includes the live auction, and freezer sale. If you have a commitment, it will be voided. Also, any student who violates this policy will forfeit all privileges of being able to show at the CCISD Livestock Show & Auction for the duration of their high school years.

- Animal abuse; this will be determined by an agriscience teacher and/or veterinarian.
- Physical alteration of the natural conformation of the animal being shown other than dehorning and castration.
- Changing out animal; the animal validated for the CCISD Livestock Show and Auction, must be the animal shown and auctioned. Animals will be verified by the following methods:
 - Hair will be pulled at selection and kept for validation on the following species: cattle, swine, lambs and goats.
 - Swine will have ear notches recorded at selection
 - Rabbits will be tattooed on January 8, 2018, tattoo numbers will be recorded.
 - Poultry wing bands will be recorded on date of delivery.

34. All CCISD market animals that are not eligible for the CCISD Livestock Show and Auction must be removed from CCISD property by 9:00 p.m. on Friday, January 18, 2018. All animals still in the barn after this time will be hauled to local livestock market and sold at market price.
35. The weight of the animal, as certified by the show management team, at the weigh-in time of the show is considered the official weight for the auction sale and the animal will only be weighed once.
36. Official weigh in will be conducted by a weigh in committee.
37. All ear tags must remain in the animal's ears after they are shown. These tags are used for identification purposes. If your ear tag is missing on Friday, February 2, 2018 for load out, you will be fined \$100.00.
38. All entered livestock must remain within the fenced show facilities until officially released. If the rule is violated, the exhibitor forfeits the opportunity to show at the CCISD Livestock Show and Auction the following school year, and forfeits all of their proceeds from the sale.

Auction Rules

1. The number of and types of sales items will be determined by the agriscience teachers upon final check-in of all entries. There will be a total of 77 lots sold in 2018.
2. The following will be the Champion and the Reserve Champion sale order for 2018:

3. All Grand and Reserve animals and Best of Show Projects must sell.
 - A student may only auction one livestock project unless he/she earns Grand or Reserve with two or more different species.
 - A student may auction one livestock project and Best of Show(s).
 - In the event a student places Grand/Reserve in more than one livestock division, the student will be allowed to auction all Grand/Reserve livestock and the Best of Show(s).
4. Agriscience teachers and their appointed show officials will conduct the CCISD FFA Livestock Show and Auction. Animals become property of the buyer when the auctioneer indicates that the sale is final.
5. Unless approved by the agriscience teachers, no pen decorations or other non-approved signs will be allowed. No "FOR SALE" sign(s) will be allowed.
6. All students with sale items in the auction must be in official FFA dress at the time of the sale.
7. Students are not permitted to wear costumes or additional items, wigs, hats, etc.
8. No paint will be tolerated on an animal during auction.

9. All exhibitors will pay a 10% commission fee on any item shown on the fair grounds that is sold during the course of the CCISD FFA Livestock Show and Auction. The money will be used to pay all show expenses.
10. Before checks for projects sold are distributed to students, they must have their “Thank You” letter approved by an agriscience teacher and proof of delivery of auction picture on file with the agriscience teacher.
11. Students failing to be present at the auction will lose the ability to show at the CCISD Livestock Show and Auction for the following school year and their animal will be sold at market value.
12. Students failing to be at their assigned pen and ready when their lot number is called for the auction will be skipped, and the animal will be sold at market value.
13. Once an animal is sold to a buyer, it is then the buyer’s property. Students are not allowed to make personal contact with buyers after the sale in regards to purchasing or having the animal donated back to them. Any student who violates this policy will forfeit all proceeds of the sale.
14. Students who do not make auction have the following options:
 - **DEFAULT:** Sell their animal in the freezer sale (which is located in the auction arena, in the back).
 - Retain ownership of the animal and select which CCISD approved processor will process the animal. *If a student chooses this option, he/she must fill out the “Freezer Sale Removal Form” and return it to the livestock office no later than thirty (30) minutes following the conclusion of the show to have their animal removed from the sale list.*
 - Retain ownership of the animal and remove the animal from the CCISD facility between 1:00 pm and 4:00 pm the day following the auction. *If a student chooses this option, he/she must fill out the “Freezer Sale Removal Form” and return it to the livestock office no later than thirty (30) minutes following the conclusion of the show to have their animal removed from the sale list. ***If the animal is not picked up by 4:00 p.m. the day following the auction, the animal will be removed from CCISD property and sold at market value by CCISD show officials.***

➤ *Animals that did not have paperwork filed to be removed from the freezer sale by January 25, 2017 must be purchased through the freezer sale the night of auction.*

15. All projects sold must be invoiced. Paperwork for the freezer sale projects MUST go through the livestock office on the night of auction.

MANDATORY THANK YOU LETTER WRITING WILL BE HELD AT EACH CAMPUS IN FEBRUARY.

Students will be given payout summaries, buyer check off sheets, and buyer's plaque for delivery upon completion of writing all thank you notes.

Agriscience Divisions of the Show

There will be fifteen (15) Agriscience Divisions of the show. Divisions will be classified and divided as follows:

Division XIV	Horticulture
Division XV	Food Science

Division I – Steers

This division is subject to the general rules and the following division rules.

1. Steers will be classified by weight. The steers will be divided into equal or nearly equal-sized classes according to number of entries and weight.
2. No hair shall be longer than $\frac{1}{4}$ ". Hair shall be allowed on the switch of the tail. Any hair found to be longer than $\frac{1}{4}$ " must be clipped prior to entering the show ring.
3. No change of the major color pattern of the animal by painting or dyeing will be allowed. Any exhibitor using grooming material that allows color to come off will disqualify the steer from competition.
4. All steers must be dehorned.
5. Steers must be healthy at show time or they will not be permitted to show.
6. Target Market weight is 1000 – 1400lbs.
7. All steers will have hair samples pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.
8. All steers must be controlled by the exhibitor in the show ring, or they will be removed from the show ring. Dismissal will be determined by the judge and CCISD agriscience teachers.

Division II – Swine

This division is subject to the general rules and the following division rules.

1. The division will be divided into an equal or nearly equal number of swine per class according to number of entries and weight.
2. Swine entries may be barrows and/or gilts.
3. No paints or powders will be permitted.
4. Swine must be healthy at show time, or they will not be permitted to show.
5. Swine will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.
6. Target market weight is 210 - 300 lbs.

Division III – Lambs

This division is subject to the general rules and the following division rules.

1. Lamb entries may be either wether or ewe lambs.
2. All lambs must be slick shorn.
3. Lambs will be divided into an equal or nearly equal number of lambs per class according to number of entries and weight.
4. No painting or changing color will be allowed.
5. Halters or collars on lambs will not be allowed in the show arena.
6. Unhealthy lambs will not be permitted to show.
7. All lambs will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.
8. Target market weight is 100 - 160 lbs..

Division IV – Market Goats

This division is subject to the general rules and the following division rules.

1. Market Goats will be divided into an equal or nearly equal number of goats per class according to number of entries and weight.
2. Goats will be handled with a collar or chain.
3. All goats must be dehorned or tipped.
4. All goats must be slick shorn to the skin above the knee and hock joints.
5. Target market weight is 80 - 110 lbs.
6. Goat entries must be wethers.
7. Unhealthy goats will not be permitted to show.
8. All goats will have a hair sample pulled, and the official paperwork will be filed with the CCISD Livestock Show Department/Management Team.

Division V – Broilers

This division is subject to the general rules and the following division rules.

1. Birds must be purchased through the CCISD Agriculture Department and must have a wing band present on the birds at show time.
2. Each student must purchase a minimum of 25 birds. Anything over the original 25 birds must be purchased in increments of 25. If you purchase more than 25 birds, you must have a separate chicken coop per order (25 birds); and you will be required to pay additional pen rent if space is available.
3. Broiler entries are limited to one pen of three birds per exhibitor.
4. All three birds must be healthy at show time.
5. Broiler entries can be cockerels or pullets.
6. Exhibitors will be allowed to present only three birds for judging. No substitutes or alternate birds are allowed after the judging begins.
7. Once poultry are checked in, they must remain in the check-in arena until shown. Please provide a box or container to house birds.
8. Only the Grand and Reserve poultry will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer. Exhibitor is responsible for feeding and watering their birds. Cages must be cleaned by 4:00 PM February 1, 2018 in preparation for the auction.
9. All shown poultry will need to be placed into the assigned pens immediately following the poultry show. All poultry will become the property of CCISD FFA Livestock Show. All non-auction birds will receive floor price.
10. CCISD Livestock Show & Auction will not floor any non-show birds.

Division VI – Turkeys

This division is subject to the general rules and the following division rules.

1. Turkeys must be purchased through the CCISD Agriculture Department and must have a wing band present on the turkey at show time.
2. Each student may purchase between 10 and 15 birds. Anything over the original 15 birds must be purchased in increments of 15. If you purchase more than 15 birds, you must have a separate chicken coop per order (15 birds); and you will be required to pay additional pen rent if space is available.
3. Turkey exhibitors are limited to one bird per exhibitor. No substitutes or alternate birds are allowed after the judging begins.
4. Once turkeys are checked in, they must remain in the check-in arena until shown. Please provide a box or container to house birds.
5. Turkey entries can be hens or toms.
6. Exhibitors will present only one bird for judging.
7. Turkey entries must be healthy in order to show.
8. Only the Grand and Reserve turkeys will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer. Exhibitor is responsible for feeding and watering their turkeys. Cages must be cleaned by 4:00 PM February 1, 2018 in preparation for the auction.
9. All shown turkeys will need to be placed into the assigned pens immediately following the turkey show. All turkeys will become the property of CCISD FFA Project Show. All non-auction turkeys will receive floor price.
10. CCISD Livestock Show & Auction will not floor any non-show birds.

Division VII- Market Rabbits

This division is subject to the general rules and the following division rules.

1. Each student must purchase their own rabbits (cost will vary depending on how much you want to spend). It is the exhibitor's choice to purchase a Buck and Doe(s) to breed a pen of market rabbits, or to purchase a pen of market rabbits. Rabbits will be kept at your home.
2. The rabbit breed must be **Californian**.
3. Suggested breeding dates for the CCISD Livestock Show are between October 20, 2017 and October 27, 2017.
4. All bunnies must be tattooed on January 8, 2018 at Clear Springs High Schools Ag. Shop from 3:00 p.m. to 5:00 p.m. The official CCISD tattoo will be placed in all of the bunnies' right ear. Individual identification tattoos will be placed in the bunnies left ear.
5. All rabbits must be healthy and free of ear mites.
6. Exhibitors may enter only one pen of three (3) rabbits.
7. Pen of rabbits, three (3), should have a target weight of 15 lbs total.
8. It is recommended that rabbits be transported in a wire bottom cage.
9. Exhibitor will be allowed to present only three rabbits for weigh-in and judging. No substitutes or alternate rabbits are allowed after weigh-in begins.
10. Only the Grand and Reserve rabbits will be displayed upon conclusion of judging. The Grand and Reserve exhibitors must provide their own feeder and waterer. Exhibitor is responsible for feeding and watering the rabbits. Cages must be cleaned by 4:00 PM February 1, 2018 in preparation for the auction.
11. CCISD Livestock Show & Auction will no longer floor any non-show rabbits

Division VIII – Breeding Heifers

This division is subject to the general rules and the following division rules.

1. Each breed division will be divided according to age and number of heifers entered to be determined by CCISD agriscience teachers.
 - a. Classes will be the following dates:
 - i. Class 1 = Junior Calves; 1/1/17 and after
 - ii. Class 2 = Yearling Calves; 5/1/16 to 12/31/16
 - iii. Class 3 = Senior Heifer; 9/1/15 to 4/30/16
2. No late entries will be accepted.
3. There will be five (5) breed divisions to include British, American, Exotic, ORB (other registered breeds), and Dairy to be shown in the above stated order.
4. A copy of the registration paper must be submitted with entry form.
5. Heifers must be healthy at show time or they will not be permitted to show.
6. All heifers must be controlled by the exhibitor in the show ring, or they will be removed from the show ring. Dismissal will be determined by the judge and CCISD agriscience teachers.
7. One overall Grand and Reserve heifer will be awarded.
8. Breeding Heifers will not be sold in the auction.
9. Each breeding heifer will need to be registered in the student's name by November 1st.
10. Heifers must be born after September 1, 2015.

Division IX – Longhorn Cattle

This division is subject to the general rules and the following division rules.

1. Longhorn cattle will be divided into two (2) different divisions, heifers and steers. Each division will then be further divided according to age and/or number of heifers and steers entered.
2. No late entries feed will be accepted.
3. A copy of the registration paper must be submitted with entry form.
4. Cattle must be registered by November 1st.
5. Only Junior Show entries will be accepted.
6. Longhorn Cattle must be healthy at show time or they will not be permitted to show.
7. All longhorn cattle must be controlled by the exhibitor in the show ring or they will be dismissed. Dismissal will be determined by the judge and CCISD agriscience teachers.
8. One overall Grand and Reserve Grand Champion Longhorn will be awarded.
9. Longhorn Cattle will not be sold in the auction.
10. Heifers must be born after January 1, 2015
11. Steers must be born after January 1, 2015
12. Steers will be divided into equal or nearly equal-sized classes according to the number of entries and weight.
13. No change of the major color pattern of the animal by painting or dying will be allowed. Any exhibitor using grooming material that allows color to come off will disqualify the heifer or steer from competition.

Division X – Showmanship

This division is subject to the general rules and the following division rules.

1. A showmanship contest will be held for the following divisions:
 - Steer
 - Heifer
 - Longhorn Cattle
 - Lamb
 - Goat
 - Swine
2. Each contest will be held immediately following the judging of each division.
3. Only those animals exhibited in the market show or breeding heifer show and selected by the judge may be exhibited in the showmanship contest by their original owner/exhibitor.
4. There is no showmanship contest entry fee.
5. The judge will designate who will be selected and evaluated for showmanship. Exhibitors will be given an item (i.e. token, stamp, etc.) which designates that they have been selected to come back and exhibit in the showmanship division.

Division XI – Floral Design

This division is subject to the general rules and the following division rules.

1. No team entries allowed.
2. There are two (2) classes in this show and they are as follows:
 1. Silk Arrangements
 2. Fresh Arrangements
3. Entries must have been conducted under the supervision of a CCISD agriscience teacher(s).
4. A portfolio/notebook consisting of a design sketch, bill of materials, and pictures of each project construction steps is required for each exhibitor's entry.
5. Anything judged with the arrangement must be sold with it.
6. No more than one entry per class per exhibitor.
7. No one will be allowed to interrupt the judge during the judging.
8. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 31, 2018.
9. If you plan to put your non-animal project(s) into the silent auction, you must notify the proper committee person at time of check-in on Wednesday, January 31, 2018. You must complete a silent auction sheet at that time complete with starting bid.
10. All students can begin taking their items starting at 4:00 p.m. on Wednesday, January 31, 2018 or after completion of judging whichever comes later. If items are entered in the silent auction and taken home they must be checked back into the silent auction by 4:00 p.m. February 1, 2018.
11. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.
12. **Best of Show Floral Design Project must sell in the auction.**

****Exhibitor is responsible for delivery of silent auction item if buyer fails to pick up on the night of auction. ****

Division XII – Agricultural Mechanics

This division is subject to the general rules and the following division rules.

1. All projects must be owned and built by the dues-paying FFA members under the supervision of a CCISD agriculture science instructor who are currently enrolled in the CCISD Agriculture Science program.
2. A student may only enter one (1) project in each class whether the project is a team or individual entry.
3. Team projects will be accepted per approval of respective agriculture science teacher.
4. All projects must be clean, painted or treated in a presentable condition even though they may have been used. Teams may not exceed four (4) members.
5. Every precaution will be taken to protect the projects entered; however, neither CCISD nor officials of this show will be responsible for loss or damage of exhibit.
6. A working plan, blueprint or drawing, photographs showing construction, and a bill of materials must be submitted with each project at time of check-in. These must be enclosed in a three-ring notebook.
7. Divisions:
 - a. Wood
 - Class 1: Individual
 - Class 2: Team
 - b. Metal
 - Class 3: Individual
 - Class 4: Team
8. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 31, 2018.
9. If you plan to put your non-animal project(s) into the silent auction, you must notify the proper committee person at time of check-in on Monday, January 29, 2018. You must complete a silent auction sheet at that time complete with starting bid.

10. All students can begin taking their items starting at 4:00 p.m. on Wednesday, January 31, 2018 or after completion of judging whichever comes later. If items are entered in the silent auction and taken home they must be checked back into the silent auction by 4:00 p.m. February 1, 2018

11. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds

12. Student(s) must be present during judging.

13. The Best of Show Agriculture Mechanics Project must sell in the auction.

****Exhibitor is responsible for delivery of silent auction item if buyer fails to pick up on the night of auction. ****

Division XIII – Visual Arts

This division is subject to the general rules and the following division rules.

1. All entries in this division are subject to the general rules and the following Visual Art rules.
2. All visual art projects must be mounted and framed.
3. No team entries allowed.
4. There are two (2) classes in this division.
 - Class 1: Photography
 - One black and white print of a person, place, or thing
 - OR
 - One color print of a person, place or thing
 - Class 2: Two Dimensional =
 - Oil – work may be on any prepared surface
 - Acrylic, Watercolor – tempera, gouache, casein
 - Pencil, Pastels, Crayon and Charcoal – must be protected with cellophane
 - Ink Drawings – may include colored ink and felt tip drawings
 - Mixed Media – two or more media combined in a single two-dimensional art
5. No more than one entry per class per exhibitor.
6. No one will be allowed to interrupt the judge during the judging.
7. All non-animal projects will be on display until 4:00 pm on Wednesday, January 31, 2018.
8. If you plan to put your non-animal project(s) into the silent auction, you must notify the proper committee person at time of check-in on Wednesday, January 31, 2018. You must complete a silent auction sheet at that time complete with starting bid.

9. All students can begin taking their items starting at 4:00 p.m. on Wednesday, January 31, 2018 or after completion of judging whichever comes later. If items are entered in the silent auction and taken home they must be checked back into the silent auction by 4:00 p.m. February 1, 2018.

10. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.

11. Best of Visual Art Project must sell in the auction and must be placed into an approved frame by the day of the live auction.

Picture/Photography Rules:

12. Photographs must be no smaller than 5" x 7" or larger than 8" x 10". The 5" x 7" photograph will be securely mounted on art board no larger than 8" x 10". The 8" x 10" photograph will be securely mounted and framed and no larger than 11" x 14". Flush mounting is acceptable (photographs must be even with edge of art board). Photographs may be matted, but mat may not exceed maximum size of 11x14 after matting. Optional: Photograph may have a "Title" on the front.

13. The committee will supply appropriate display devices.

14. Two-Dimensional Art may not exceed 16" x 20".

****Exhibitor is responsible for delivery of silent auction item if buyer fails to pick up on the night of auction. ****

Division XIV – Horticulture

This division is subject to the general rules and the following division rules.

1. Entries must have been conducted under the supervision of the agriscience teacher(s).
2. A portfolio/notebook consisting of a design sketch, bill of materials, and pictures of each project construction steps is required for each exhibitor's entry.
3. No more than one entry per class per exhibitor.
4. All non-animal projects will be on display until 4:00 pm on Wednesday, January 31, 2018.
5. If you plan to put your non-animal project(s) into the silent auction, you must notify the proper committee person at time of check-in on Wednesday, January 31, 2018. You must complete a silent auction sheet at that time complete with starting bid.
6. All students can begin taking their items starting at 4:00 p.m. on Wednesday, January 31, 2018 or after completion of judging whichever comes later. If items are entered in the silent auction and taken home they must be checked back into the silent auction by 4:00 p.m. February 1, 2018.
7. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.
8. Team entries are not allowed.
9. Horticulture classes will consist of the following:
 - Class 1: Container plant (single specimen in a traditional container)
 - Class 2: Hanging plant (single specimen)
 - Class 3: Dish Garden (Multi-specimen in a hanging basket or traditional container)
 - Class 4: Terrarium (single specimen in a mostly glass container)
 - Class 5: Novelty Container
10. **Best of Show Horticulture Project must sell in the auction.**

****Exhibitor is responsible for delivery of silent auction item if buyer fails to pick up on the night of auction. ****

Division XV – Food Science

This division is subject to the general rules and the following division rules.



REQUIRED

1. For judging purposes, two typed copies of a recipe must accompany all food entries on a recipe card attached to the item. The name of the recipe must be on the front of the card with the exhibitor name and school on the back of the card. All food is judged on appearance, color, texture, and flavor of the food only
2. Entries will be displayed on disposable plates and covered with a see-through top (plastic wraps securely fastened, commercial plastic, etc.). Absolutely no containers will be returned.
3. If your food item requires refrigeration, it is the exhibitor's responsibility to make arrangements to keep their food item cool (i.e. displaying entry in a container with ice.)
4. A display of small items such as cookies must contain a minimum of two (2) dozen items.
5. No more than one entry per class per exhibitor.
6. Classes are as follows:
 - Class 1 = Cookies: brownies, bar cookies, drop, rolled, cut out, etc.
 - Class 2 = Cakes: layered, cupcakes, Bundt, etc.
 - Class 3 = Pies: fruit or double crust
 - Class 4 = Breads: muffins, coffee cakes, loaves, etc.
 - Class 5 = Decorating Cake Class (Entries must be edible)
7. All non-animal projects will be on display until 4:00 p.m. on Wednesday, January 31, 2018.
8. If you plan to put your non-animal project(s) into the silent auction, you must notify the proper committee person at time of check-in on Wednesday, January 31, 2018. You must complete a silent auction sheet at that time complete with starting bid. Food items for the silent auction need to be recreated and brought to the fairgrounds February 1, 2018 by 4:00 p.m.

9. All students can begin taking their items starting at 4:00 p.m. on Wednesday, January 31, 2018 or after completion of judging whichever comes later. If items are entered in the silent auction and taken home they must be checked back into the silent auction by 4:00 p.m. February 1, 2018.
10. CCISD will not be responsible for any damage or loss of a project while it is being displayed, judged, or moved on the school grounds.
11. Team entries are not allowed.
12. **Best of Show Food Science must sell in the auction, and the exhibitor must furnish a fresh duplicate for the live auction on February 1, 2018.**
